
Theme 6: Reasons to leave


Butte County

Risk reduction





I lost a bunch of weight like just from stress... We're like, okay, we'll keep looking around here. And we just watched the prices rise over probably the first three months we watched them like you'd see a home that was \$200,000 I'm just going to use that number like shoot up to \$300. That's a 50% raise like we were seeing that all over the place. Homes that we really wanted, like the ones that ended up used to get listed for like \$315 or \$330... I'm like, we can't afford these if they keep going up, Like we're going to get pushed out of California or pushed out of the area.

Well, the fire destroyed a lot of, well, what I say about the first fire, and it's true for the ten years later, it just it destroyed our networking our, the fabric of our community. Our togetherness and our family and friends and neighbors. I was, I lived on a piece of property with eight land partners, and we were really into being back to the land, and down to earth, and real simple living in and really bonded with our neighbors. But when our structure, so many were destroyed, and we had to move elsewhere to find shelter.

It broke those ties of the you know community network that we had and that was, so in a way, the fire, the loss of the structures was not as important or not as damaging to our being as the loss of our freedom and our way of living. Sonoma County
